Please do not mail Memberships to USEF, they will not be electronically verifiable and non-member fees will be charged. Incomplete entry forms will be charged a fee of \$50 (considered late entry) and will be required to show proof of membership, etc. before number will be released. Competitors are responsible for their own errors and those of their agents in the preparation of their entry forms. Please ensure your entry form has been properly filled out.

2024 USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Federation Entry Agreement: By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of 2024 Winter Spectacular Show Series (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in USEF's sole discretion. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. USEF may in its sole discretion, at any time, terminate my USEF Fan status. I acknowledge that I may opt out at any time by going to My USEF Dashboard or calling (859) 810-8733.

STATEMENT AS TO FEDERATION FEE

(GR407.1-3) For every horse participating in any competition licensed by the Federation, a \$23 Federation Fee will be collected (\$15 shall be an Equine Drugs & Medication Fee to provide for research, inspection, and enforcement of rules regarding use of medications and drugs & \$8 USEF Fee) along with a \$7 USHJA Fee and USHJA Showpass \$30. USEF Membership is required.

The Horse Show Management reserves the right in itself to interpret all questions and conditions in regard to or arising out of an incident without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management, their decision to be final.

The Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without claim for damages; to change any course, to add a dotted line, to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the time schedule or as competition warrants, or make any changes management deems is in the best interest of the show and its exhibitors.

Every horse entered for competition will be under the control of the Horse Show Management, but Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its members, directors and employees, contractors, sponsoring entities and facility harmless for any loss or accident to horse, horses or equipment which may occur from sickness, fire or otherwise

SAFE SPORT STATEMENT: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

NECROPSY: I understand that any horse/pony "fatality" defined as a death by any means including euthanasia, at any time from when entries arrives at the Venue until departure from the Venue, or a death by any means including euthanasia at any time occurring as a result of any fatal injury or illness sustained during any WEC Event shall result in a necropsy. For any necropsy the Owner of the horse/pony shall perform a gross mortem examination and the Owner hereby agrees to share all findings, results and medical reports with WEC. In the event an Owner does not perform a gross post mortem examination of the horse/pony, the Owner hereby authorizes WEC to perform the gross post mortem examination at its sole cost and expense and agrees to share the results with Owner.

In the event an Owner's horse/pony dies from a disease that affects (an) other horse(s)/pony(ies) at the Venue the Owner of the deceased horse/pony agrees to indemnify any other third party Owner of a horse/pony affected and further agrees to indemnify and hold WEC harmless from any claim, demand, or liability arising out of or in any way related to the deceased horse/pony.

CONDITIONS

Office Hours: Office closes at 5pm daily OR 30 minutes after the last class finishes, whichever comes FIRST. Adds for the next day must be completed by 4pm.

Important USEF rules in effect: As of Jan 1, 2019 every USEF adult member (18 years of age or older) with a Competing Membership must complete USEF's Safe Sport Training. You will do this when logged into your USEF account, preferably when you renew your membership. Failure to complete the safe sport training will disqualify you from competing in any capacity until it is completed. Do not get caught on the suspended list. Junior riders that have reached their 18th birthday must complete Safe Sport training.

Photography: Andrew Ryback Photography is the official photographer of the 2024 November and December Show Series at World Equestrian Center - Ocala. By entering the premises of World Equestrian Center (WEC), you enter an area where photography, audio and video recording may occur. By entering the property, you consent to photography, audio and/or video recording, and the release, publication, exhibition or reproduction to be used for news, web, social media, advertising and other promotional purposes by WEC and its affiliates and representatives. In entering the WEC grounds, you release WEC, its officers and employees, and each and all persons involved from any liability connected with the taking, recording, digitizing, or publication and use of interviews, photographs, images, video and/or audio recordings. All rights to royalties, claims of payment in connection with any use of the media materials listed above, are waived, regardless of whether a fee or admission is charged or sponsorship applied. You have been fully informed of your consent, waiver of liability, and release before entering WEC grounds.

Mandatory Microchipping went into effect on December 1, 2018. You will not be allowed to COMPETE any horse that has not been microchipped. The microchip must be uploaded to your USEF account. All horses that require a USHJA Registration will also require a microchip.

Stabling: All stalls (12'X12' and 12'X14') are permanent concrete stalls with doors, stable comfort mattress systems, and fans. Stalls may not be occupied by more than one horse at a time. Stalls may not be sublet or incur a sublet fee of \$50.

Weekly Stall/Paddock Reservations: Stalls are \$305/week. Stalls and Paddocks can be reserved on HorseShowing.com. Paddocks are \$375/week and subject to availability (Horses may not be turned out in paddocks between dusk and dawn). No reservations will be accepted through email. Please understand that we are unable to accept location requests at this time.

Horses are not allowed in locking tack rooms. A \$50 cleaning up fee per stall and/or tack room will occur for any left behind personal belongings and trash. Shavings are to be purchased on-site. Any off-site shavings will result in an additional \$25 manure disposal fee per stall. A \$100 fee per stall and/or tack room will occur for any nails or screws in stalls/tack rooms.

For ordering tack stalls, paddocks, feed and bedding that is intended to be included in a trainer split, a form of payment is required in the Horse Show Office. Splits are due in the Horse Show Office by 4pm Friday of each given show week.

Stalls/paddocks are property of World Equestrian Center. All horses on grounds will be charged for a stall or ship-in fee.

Feed and Bedding: Must be ordered through <https://worldequestriancenter.jotform.com/form/223222771406146> at least 24 hours in advance to guarantee delivery prior to arrival. No outside shavings deliveries or cardboard shavings permitted.

Ship In Fee: \$150/week. Park in designated area only. Any horse not entered to show will also be charged the appropriate non-showing fees. Any horse not paying the horse show for a stall will be charged a ship-in fee.

Entry Closing: Online entries must be submitted two weeks prior to the start of the competition week. Submit online entries through HorseShowing.com. Late fee is \$50 after the closing date for online entries/ \$75 for paper entries.

Checking In and Checking Out: All horses must leave a check or credit card on file. All accounts must be settled EVERY WEEK, in full, upon the conclusion of the final class on Sunday. Those that do not check out or leave an open check with the office will be charged a \$50 late check out fee for each day past Sunday.

Email ocalacheckout@wec.net to request a link to pay your bill online. Include horse name/back number in email.

All Horses on Property: As of December 1, 2023 all horses must be issued a back number from the Horse Show Office and it must be worn at all times when out of the stall or trailer.

IMPORTANT INFORMATION CONCERNING SPLITTING/COMBINING & ADD/SCRATCH POLICY IN ALL "A" RATED HUNTER SECTIONS: Should entries warrant, all "A" rated hunter sections will be split or combined following USEF rules and will be done so at the close of the horse show office on the evening preceding the first class in each section, therefore entries MUST be completed for "A" rated hunter divisions accordingly to be considered. Any post-adds received and accepted after this time will not be considered in respect to the splitting/combining numbers. There will be no exceptions to this policy. Same day scratches and/or "no-shows" at the gate in all "A" rated hunter sections will forfeit their entry fee unless a Certificate from the Official Show Veterinarian vet scratch for the show is received by the official show secretary prior to the First class of the section in question. Should same day scratches or no-shows result in insufficient entries to keep sections split, sections will be combined.

Adding Classes: Can be done directly through **HorseShowing.com** or in horse show office until 4pm the day before the class is scheduled. Please be sure to enter classes in a timely manner. Scheduling cannot accommodate same day adds. In the event an add after 4pm the day prior is approved by management, a \$25 late add fee will incur.

*****RDNE (Rode Did Not Enter):** Entries that show in a class that was not properly entered either online, by inclusion on your original entry form, or a properly filled out add slip/online add PRIOR to the class involved will be charged a \$50 RDNE Fee.

Scratching Classes: Scratches can be done directly in your **HorseShowing.com** account any time until the start of the class except "A" rated hunters cannot scratch same day. Informing the starter that you do not intend to participate WILL NOT scratch the class. A horse on the grounds scratching all classes will become a non-showing horse regardless of the reason and will incur all fees associated with a non-showing horse. After showing in the first class of any "A" rated section requiring a section entry fee, no refunds will be given for scratching any classes within the section for any reason.

Non-Showing Horses: All horses on the grounds are required to have a signed entry form in the office, whether they are showing or not. This entry form must include signatures and a complete description of the horse. All horses must present health paper upon arrival to the Show Office.

Award Ceremonies: Riders are required to ride for awards in all Classics/Grand Prix, unless notice of ceremony cancellation has been given. Failure of a rider to be present may result in forfeiture of all prizes won in the class. Competition management reserves the right to require participation in any tie-breaking procedure in order to determine a winner of a competition or championship. Refusal to participate in the tie-break procedure (if required) may include, but is not limited to; forfeiture of prize money and/or elimination from the competition. The decision of management is final.

Payment Method: Show Fees may be paid by cash, check drawn on an American bank, or any major credit card (3% fee).

Returned Checks/Declined Credit Cards/Credit card chargebacks: Checks returned by the bank or declined credit cards or chargebacks on credit cards transactions for any reason are regarded as a serious offense and will be handled as follows: A 10% penalty will be assessed for every returned check or credit card chargeback (Minimum of \$50). Accounts will be given ten days to be paid in full with cash or cash equivalent or they will be reported to USEF for collection/disciplinary action.

Prize Money/Awards: An IRS W9 needs to be completed showing the proper prize money recipient and their SS or FED ID#. Care must be taken to be sure the information matches that of the IRS. Prize money will be deducted from your account upon closeout in the office provided you have submitted the required W9 or W8 for Foreign exhibitors. Balances will be paid by check and mailed to the named recipient on the W9 within 30 days after the conclusion of the show. The IRS W9 form is available in the show office/through **HorseShowing.com** account. All Hunter purses shall be divided as follows unless otherwise specified: 1st-30% / 2nd-22% / 3rd-15% / 4th-12% / 5th-11% / 6th-10%. All hunter classic purses shall be divided as follows unless otherwise specified: 1st-25% / 2nd-19% / 3rd-15% / 4th-10% / 5th-9% / 6th-8% / 7th-7% / 8th-7%. Ribbons will be awarded to eighth place in all hunter classes. \$75,000 in hunter prize money is guaranteed to be paid out each week.

Refunds: Entries canceled prior to the closing date will be refunded in full. Stalls and processing fee are not refundable for any reason after the closing date. All scratches must be submitted in writing to be considered for a refund. All accounts become final after the close of the show, changes will not be considered after this date, no exceptions! Please look over your statement carefully before checking out. If the show must be stopped due to a storm, accident, or other emergency, the show management has the right to deny a refund of any or all fees. Refunds will be issued at the end of series.

Processing/EMT/Night Watch: Each horse will pay a \$111 per show Processing Fee. The Processing Fee is a non-refundable fee which will also entitle each horse to properly add/scratch regular classes at no additional cost.

Arrival and Departure: Horses may arrive after 3pm on Monday and depart no later than 7am Monday. Early arrival and late departure must be arranged directly with the stabling manager.

Health Requirements: Florida regulations require that all equines be covered by official interstate health certificates, issued by a licensed veterinarian, showing that the animals are free from any symptoms of any infectious or communicable disease. The certificate shall include the name of the owner and address, destination in Florida, number of horses examined, the name, registration number(s), if any, tattoo, if any, sex, age, rectal temperature, color, and markings of each animal listed. Health certificates will become void after 30 days from issue. Health certificates must show animals to be negative to an equine infectious anemia test within the past 12 months. Date of test and approved laboratory must be shown on health certificate. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee.

Rings: WEC Grand Arena is 320' x 400', Stadium 390' x 390', Jumper 1 200' x 300', Jumper 2 200' x 300', Jumper 3 180' x 300', Jumper 4 180' x 300', Indoor 1 173' x 533', Indoor 2 175 X 533', Indoor 3 173' X 533', Indoor 4 173' x 533', Hunter 1 175' x 300', Hunter 2 175' x 300', Hunter 3 175' x 300', Hunter 4 175' x 300', footing is GGT mix. Indoor 5 160' x 473' sand clay.

Courtesy Circle: In some instances it may become necessary to restrict the area of the courtesy circle by a mandatory line. If this is implemented, it will be clearly marked on the course chart and a corresponding barrier will be erected on the course. A public announcement will also be made.

Motorized Vehicles: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Dogs - Leash Law: Dogs and other pets must be on a leash at all times while on the show grounds. Fines for dogs found without a leash will result in a \$100 fine. No dog pens are allowed outside of the barns or in shared aisles. No dogs in stalls overnight.

Medical Waste: Sharps must be placed in proper receptacles located in each barn. Failure to do this will result in a \$100 fine or other penalties deemed necessary by the show management.

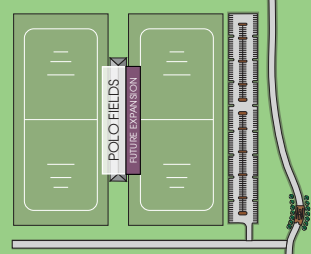
Protective Headgear: It is compulsory for all persons at Federation licensed hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. It is the responsibility of the rider, or the parent, guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards and is properly fitted and in good condition.

Poling: Manual poling and the use of bamboo offsets are prohibited at all times on the grounds of the World Equestrian Center. In the event of a violation of this rule, the involved horse and its trainer of record as indicated on the entry form will be suspended from further competition at the show in which the violation occurred. In addition, no refunds will be given for any unused fees.

Emergency Information: All horses must have an emergency information card attached to their stall.

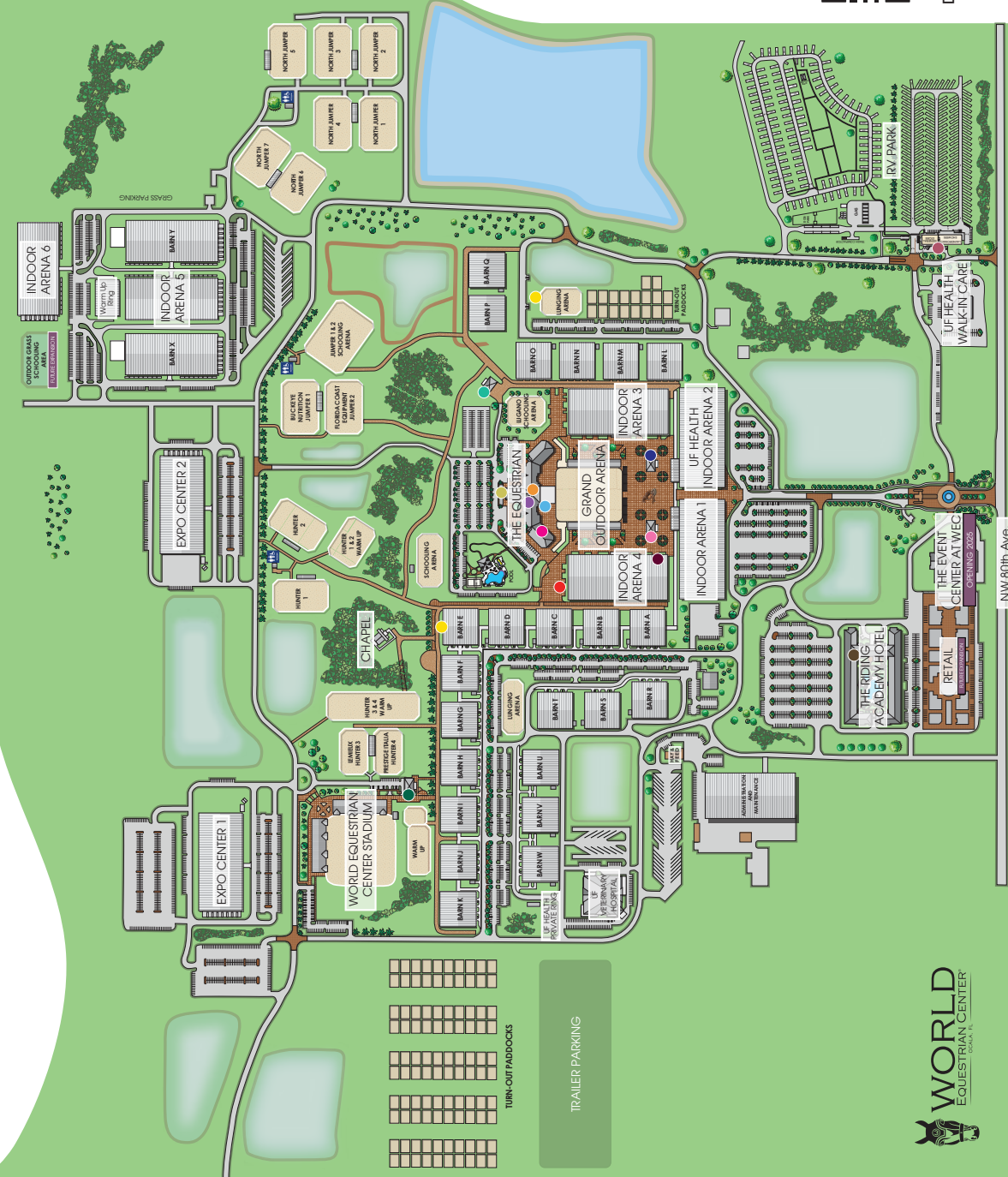
Horse Show Championships: In all Hunter Championships, the titles shall be awarded to two of the four horses which have acquired the most points over fences. In addition to these points, only these four horses shall receive full points for ribbons won in Under Saddle classes and half points for ribbons won in Model. Equitation Championships shall be equal points with ties broken by points over fences. Points awarded for all divisions as follows: 10-6-4-2-1-1/2 except Jumper bonus classes. Ties in USEF Hunter Championships shall be decided as specified in the USEF Rule Book. Others shall remain tied and shall flip/draw for the awards. Ties in Jumper divisions to be decided by the bonus class placing, if still tied they shall remain tied and entries shall flip/draw for the awards.

Horse/Pony Measurements: Measurements will take place Wednesday through Saturday at 10am at the Vet station in Barn E. Please make arrangements in the Horse Show Office.

HUNTER DIVISIONS

All hunter classes that require a jog will be run with an open numerical score announced at the end of each round.

Hunter Courses: Courses will consist of at least eight fences with changes of direction. Fences will simulate obstacles found in the hunt field, such as brush, post and rails, walls, in and outs, gates, etc. No bank or water jumps. Course diagrams will be posted no later than 30 minutes before the class. In some cases, the area of the courtesy circle may be restricted by a dotted line. Under Saddle classes to be shown at a walk, trot and canter both ways of the ring. No martingales permitted. In High Performance, A/O and Junior classes, entries may be asked to hand gallop collectively one way of the ring, at the Judge's discretion. No more than eight shall be asked to hand gallop at one time. Minimum entry requirements: Management reserves the right to combine Sections with less than six entries. No split Section will be held with less than four entries. Handy Hunter Courses and jumps to simulate those found in trappy hunt country, and may include natural obstacles, a trot fence and a fence to lead over. Jogging - The traditional manner of jogging for soundness in hunter classes is waived, and horses and ponies will jog for soundness under saddle by trotting a circle on a loose rein at the end of each over-fences performance.

- To be judged on performance and soundness, suitability to count.
- Horses and Ponies are not required to jog for soundness.

ELIGIBILITY FOR ADULT AMATEURS: HUNTER, JUMPER AND EQUITATION:

- To be ridden by exhibitors who have reached their 18th birthday as of December 1 of the current competition year and who hold a current USEF Amateur certification. Open to horses and ponies.

ELIGIBILITY FOR CHILDREN'S SECTIONS: HUNTER, JUMPER AND EQUITATION:

- To be ridden by exhibitors who have not reached their 18th birthday as of December 1 of the current competition year.

ADULT AMATEUR HUNTER

Sections offered and requirements:

- Adult Amateurs – may be split into three (3) sections

Cross Entry:

Rider:

Riders in this section may enter any Equitation class and any class where otherwise eligible. Riders who compete in the Amateur Owner Hunter and/or Jumper classes may show other horses that they own in the Adult Amateur Hunters. Riders competing in the Amateur Owner 3'3" section (but not competing in the Amateur Owner 3'6" section) may ride one horse that they do not own in the Adult Amateur Hunter section.

Horse:

Horses and ponies exhibiting in this section may cross enter multiple sections of Adult Amateur Hunter and any classes where eligible.

Fence height:

- 3'0" with spreads not to exceed the fence height.
- Courses will not be adjusted for ponies.
- ***In and outs*** will be permitted.

Combining/Dividing Sections:

May be split into three sections:

- Adult Amateurs 18– 35
- Adult Amateurs 36– 49
- Adult Amateurs 50 & over

The Adult Amateur Hunter section may be divided by age of rider and/or height of fences. If there are fewer than three (3) entries in a section, that section must be combined with another Adult Amateur section. The Adult Amateur Hunter section may be combined with the Children's Hunter section when there are fewer than three (3) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

Classics: Adult Amateur Hunter Classics

Four (4) entries are required to conduct an Adult Amateur Hunter Classic. If there are fewer than Four (4) entries in any one Adult Amateur Hunter Classic, it may combine with other sections of Adult Amateur Hunters or Children's Hunter Horse. If Adult Amateur Hunter Classics are combined and a horse is shown in more than one section qualifying for the Adult Amateur Hunter Classic, the exhibitor must declare their point section to the Competition Secretary on a declaration form at the time of entry into the Classic. Adult Amateur Hunter Classics cannot be divided in any manner and held by section if there are fewer than six (6) entries in each divided section.

Riders may not cross enter into any class or section at the same competition where fences exceed 3'3" (Exception: All Equitation classes). Riders who compete in the 3' Adult Hunters and/or the 3'3" Amateur Owner Hunter classes may show horses that they own in the Low Adult Hunters and one that they do not own in the Low Adult Hunters.

Low Adult Amateur Hunter horse/rider combinations may not cross enter into any classes or section where fences exceed 2'9".

Fence height:

- 2'6"

Combining/Dividing Sections:

The Low Adult Amateur Hunter section may be combined with the Low Children's Hunter section when there are fewer than four (4) entries in either section. If sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

Awards:

Zone Horse of the Year Awards will be presented annually to the following section:

- Low Adult Amateur Hunter

AMATEUR JUMPER

Sections offered and requirements:

- 1.00/1.05m Amateur Jumper
- 1.10/1.15m Amateur Jumper

Cross Entry:

Competition Management may restrict cross entries between 1.10/1.15m and 1.00/1.05m sections at the same competition if stated in the prize list.

Rider:

Riders competing in an Adult Amateur Jumper Classic may not compete in any other Jumper Classic above 1.15m, Welcome Stake, Mini Prix, or Grand Prix at 1.30m or above or in the highest prize money class of any 1.30m or above section at the same show.

Horse and Rider Combination:

1.00/1.05m Amateur Jumper horse/rider combinations may not cross enter into any classes held above 1.15m at the same show. 1.00/1.05m Amateur Jumper horse/rider combinations may enter only one classic, if both 1.00/1.05m and 1.10/1.15m are offered.

1.10/1.15m Amateur Jumper horse/rider combinations are not permitted to cross enter into Amateur Owner Jumper classes or any class at 1.20m and above, that offers prize money, at the same competition. 1.10/1.15m Amateur Jumper horse/rider combinations may enter only one classic, if both 1.00/1.05m and 1.10/1.15m are offered.

Fence Height:

- Amateur Jumper 1.00m to 1.05m
- Amateur Jumper 1.10m to 1.15m

Combining/Dividing Sections:

Children's sections may be divided by or combined with Adult Amateur Jumper sections, at management's discretion, if so stated in the prize list.

Awards:

Zone Horse of the Year Awards will be presented annually to the following sections:

- 1.00/1.05m Amateur Jumper
- 1.10/1.15m Amateur Jumper

EQUITATION

AGE GROUP EQUITATION: ADULT SECTION

Sections Offered:

- Adult Equitation 18- 35
- Adult Equitation 36 & Over

Cross Entry:

No cross entry restrictions.

Fence Height:

- Minimum 2'9", maximum 3'3" - management must state height at which class will be offered.
- Management may offer multiple height options if stated in the prize list, but each course must be set at the same height throughout.
- Course design must comply with EQ108.11 except combination is optional.
- Spreads not to exceed fence height

Combining/Dividing Sections:

Age-Group Equitation Sections may be combined as necessary, jumping at their respective heights, to meet the three (3) entry minimum requirement for points to be awarded. Stallions are prohibited when adult equitation sections are combined with children's/junior equitation sections. EQ101.3.

Awards:

Zone Horse of the Year Awards will be presented annually to the following section:

- Adult Equitation 18- 35
- Adult Equitation 36 & Over

CHILDREN'S HUNTER HORSE

Sections offered and requirements:

- Children's Hunter Horse 14 & Under
- Children's Hunter Horse 15- 17

Cross Entry:

Rider:

Riders in this section may enter any Equitation class and may compete with one different horse in the Junior 3'3" Hunter section but may not cross-enter into any Junior 3'6" Hunter or Junior Jumper class at the same show.

Horses/Ponies:

Horses and ponies exhibited in this section may cross enter multiple sections of Children's Hunter and any classes where eligible.

Fence Height:

- 3'0" with spreads not to exceed fence height
- In and outs will be permitted

Combining/Dividing Sections:

The Children's Hunter Horse section may be divided by age of rider and/or height of fences. If the Children's Hunter Horse section is offered divided by age it will be divided: Children's Hunter Horse 14 & Under and Children's Hunter Horse 15- 17. If there are fewer than three (3) entries in either age section, the two sections must be combined. The Children's Hunter Horse section may be combined with the Children's Hunter Pony, when there are fewer than three (3) entries in either section. Alternatively, the Children's Hunter Horse section may be combined with the Adult Amateur section when there are fewer than three (3) entries in either section. The Children's Hunter (horse & pony) section may be combined with the Adult Amateur section when there are fewer than three (3) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

Classics: Children's Hunter Horse Classics

Four (4) entries are required to conduct a Children's Hunter Horse Classic. If there are fewer than Four (4) entries in any one Children's Hunter Horse Classic, it may combine with other sections of Children's Hunter Horse or Adult Amateur Hunters. If Children's Hunter Horse Classics are combined and a horse is shown in more than one section qualifying for the Children's Hunter Horse Classic, the exhibitor must declare their point section to the Competition Secretary on a declaration form at the time of entry into the Classic. Children's Hunter Horse Classics cannot be divided in any manner and held by section if there are fewer than six (6) entries in each divided section.

Awards:

Zone Horse of the Year Awards will be presented annually to the following sections:

- Children's Hunter Horse 14 & Under
- Children's Hunter Horse 15- 17

LOW CHILDREN'S HUNTER HORSE

Eligibility:

Open to exhibitors who have not yet reached their 18th birthday as of December 1 of the current competition year.

Cross Entry:

Rider:

Riders may not cross enter into any class or section at the same competition where fences exceed 3'3" (Exception: All Equitation classes). Riders who compete in the 3' Children's Hunter Horse, Regular A Rated Pony Sections, and/or Junior Hunter 3'3" classes may show one horse in the Low Children's Hunter.

Horse and Rider Combination:

Low Children's Hunter horse/rider combinations may not cross enter into any classes or section where fences exceed 2'9".

Fence height:

- 2'6"

Combining/Dividing Sections:

The Low Children's Hunter section may be combined with the Low Adult Amateur Hunter section when there are fewer than four (4) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

Awards:

Zone Horse of the Year Awards will be presented annually to the following section:

- Low Children's Hunter Horse

CHILDREN'S HUNTER PONY

Sections offered and requirements:

- Small/Medium Children's Pony
- Large Children's Pony

Cross Entry:

Rider:

Rider age restrictions as found in Regular Pony sections do not apply. Riders may show only one pony in either the 2'0" or the 2'6" height of the Children's Hunter Pony section when also competing in the Regular Small, Medium or Large Pony and/or Green Pony Hunter sections. Riders cannot cross enter into any class where fences exceed 3'3" (exception: Riders may show in Pony Jumpers).

Horse/Pony:

Ponies exhibiting in Children's Hunter Pony may cross enter into any class where otherwise eligible, but the rider may not show the same pony in the regular pony section. Note: The pony may only be shown by one rider in the Children's Hunter Pony Classic and that rider must be declared prior to the first round of the Classic.

Fence Height:

- Small/Medium Ponies: 2'0" with spreads not to exceed height of fence.
- Large Ponies: 2'6" with spreads not to exceed height of fence.
- In and outs will not be permitted

Combining/Dividing Sections:

The Children's Hunter Pony section may be divided by size. If the Children's Hunter Pony is offered divided by size it will be divided: Children's Hunter Pony Small/Medium and Children's Hunter Pony Large. If there are fewer than three (3) entries in either height section, the two sections must be combined. The Children's Hunter Pony section may be combined with Children's Hunter Horse when there are fewer than three (3) entries in either section. The Children's Hunter (horse & pony) section may be combined with the Adult Amateur section when there are fewer than three (3) entries in either section. When sections are combined there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

Awards:

Zone Horse of the Year Awards will be presented annually to the following sections:

- Children's Hunter Pony-Small/Medium
- Children's Hunter Pony-Large

LOW CHILDREN'S HUNTER PONY

Eligibility:

Open to exhibitors who have not yet reached their 18th birthday as of December 1 of the current competition year. Stallions are prohibited from all Low Children's Pony Hunter classes. Individual classes may be entered. (Exception: Under Saddle classes. See HU129.2).

Low Children's Hunter Ponies are not required to jog for soundness.

Cross Entry:

Riders:

Low Children's Hunter Pony Riders may not cross enter into any class with fence heights that exceed 2'9" or into the Children's Hunter Pony, Pony Hunter, or Green Pony Hunter Section at the same competition.

Pony:

Ponies exhibiting in Low Children's Hunter Pony may cross enter into any class where otherwise eligible, but the Rider may not show the same pony in the Regular Small, Medium or Large Pony, Green Pony Hunter and/or Children's Hunter Pony sections. A pony may only be shown by one rider in the Low Children's Hunter Pony Division. In the Low Children's Hunter Pony Classic the Classic rider must be declared prior to the first round of the Classic.

Fence Height:

- 2'0"

Combining/Dividing:

Combining:

If there are fewer than three (3) ponies in the Low Children's Hunter Pony section, they may combine with the Low Children's Hunter Horse section. If there are still fewer than three (3) entries after the Low Children's Hunter Pony section has been combined with the Low Children's Hunter Horse section, these sections may only then combine with the Low Adult Amateur Hunter Horse section.

Dividing:

Low Children's Hunter Pony may be divided if there are more than 20 entries in the Division

Awards:

Zone Horse of the Year Awards will be presented annually to the following section:

- Low Children's Hunter Pony

JUNIOR JUMPER

Sections offered and Requirements:

- 1.00/1.05m Junior Jumper
- 1.10/1.15m Junior Jumper

Cross Entry:

Competition Management may restrict cross entries between 1.10/1.15m and 1.00/1.05m sections at the same competition if stated in the prize list.

Rider:

Riders competing in a Children's Jumper Classic may not compete in any other Jumper Classic above 1.15m, Welcome Stake, Mini Prix, or Grand Prix at 1.30m or above or in the highest prize money class of any 1.30m or above section at the same show.

Horse and Rider Combination:

1.00/1.05m Junior Jumper horse/rider combinations may not cross enter into any classes held above 1.15m at the same show. 1.00/1.05m Junior Jumper horse/rider combinations may enter only one classic, if both 1.00/1.05m and 1.10/1.15m are offered.

1.10/1.15m Junior Jumper horse/rider combinations are not permitted to cross enter into Junior Jumper classes or any class at 1.20m and above that offers prize money, at the same competition. 1.10/1.15m Junior Jumper horse/rider combinations may enter only one classic, if both 1.00/1.05m and 1.10/1.15m are offered.

Fence Height:

- Junior Jumper 1.00m to 1.05m
- Junior Jumper 1.10m to 1.15m

Combining/Dividing Sections:

Adult Jumper sections may be divided by or combined with Children's Jumper sections, at management's discretion, if so stated in the prize list.

Awards:

Zone Horse of the Year Awards will be presented annually to the following section:

- 1.00/1.05m Junior Jumper section
- 1.10/1.15m Junior Jumper section

AGE GROUP EQUITATION: CHILDREN'S/JUNIOR SECTION

Sections Offered:

- Equitation 11 & Under
- Equitation 12- 14
- Equitation 15- 17

Cross Entry:

No cross entry restrictions.

Fence Height:

- Equitation 11 & Under
 - Minimum 2'0", maximum 2'6" - management must state height at which class will be offered.
 - Management may offer multiple height options if stated in the prize list, but each course must be set at the same height throughout.
 - Course design must comply with EQ108.8 and 108.11, combinations not permitted.
- Equitation 12- 14
 - Minimum 2'9", maximum 3'3" - management must state height at which class will be offered.
 - Management may offer multiple height options if stated in the prize list, but each course must be set at the same height throughout.
 - Course design must comply with EQ108.11 except combination is optional.
- Equitation 15- 17
 - Minimum 3'0", maximum 3'6" - management must state height at which class will be offered.
 - Management may offer multiple height options if stated in the prize list, but each course must be set at the same height throughout.
 - Course design must comply with EQ108.11 except combination is required.
- Spreads not to exceed fence height

Combining/Dividing Sections:

Age-Group Equitation Sections may be combined as necessary, jumping at their respective heights, to meet the three (3) entry minimum requirement for points to be awarded. Stallions are prohibited when adult equitation sections are combined with children's/junior equitation sections. EQ101.3.

- Equitation 15-17

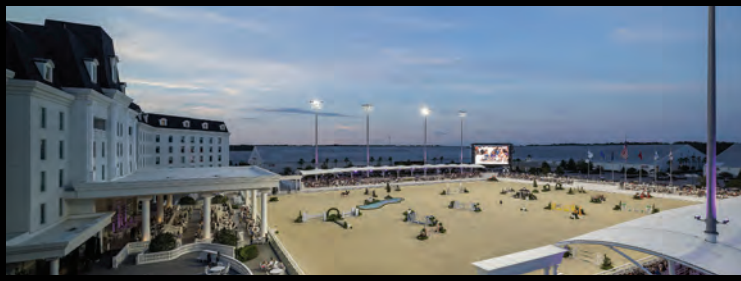
