

WORLD EQUESTRIAN CENTER – OCALA RV PARK AND GOLF CART RENTAL DIRECTIVES



RV PARK: KNOW BEFORE YOU STAY

- Sites include the use of water, sewer and electric (10/30/50 amp)
- All site rentals accommodate one RV and one vehicle
- All prices are based on a two-person occupancy. Additional persons six years or older are charged \$5 per night/per person
- Renters are required to remove their own trash. Failure to comply will result in a \$50 clean-up fee
- Garbage dumpsters are located on white cemented drive (behind trees) directly south of the fuel station
- Please report any site issues to the manager at the General Store upon arrival; otherwise, you will assume responsibility for the condition of your site upon departure



PROHIBITED WITHIN THE RV PARK

- Washing RVs in RV slips
- The use of tents or pop-ups (all units must have a self-contained bathroom)
- Inflatable items of any kind, including pools
- Fire pits or open flames



PET POLICY

- The RV park, and WEC facility, is largely dog friendly (with some exclusions)
- Dogs must remain leashed at all times
- Dog owners and renters of the RV site bear full responsibility for the behavior of their dog(s), in addition to assuming full liability for any resulting damages and/or injury caused by or involving their dog(s)

RV CAMPSITE DEPOSIT AND PAYMENT PROCESS:

- **Reservations** | Non-transferable. A credit card and ID are required at time of reservation. Card will not be charged until time of check-in unless reservation is canceled, and cancellation is subject to penalties described under 'Cancellations & Refunds' section. Reservation and rates are subject to availability and change.
- **Daily & Monthly** | Full payment for the entire length of stay, including applicable taxes, is required at time of check-in. All monthly rates are based on 30-day stays; prorated rates are not applicable.
- **Payment Method** | MasterCard, Visa, American Express, Discover or cash accepted; however, a credit card must remain on file for the duration of the rental. Please note: a \$50 per night incidental hold will be placed on card during duration of stay.
- **Liability** | RV Site Renter assumes all liability for any damages incurred during use; all vehicles will maintain proper vehicle general casualty and liability insurance and be able to produce evidence of coverage while on WEC property.
- **Cancellations & Refunds** | All reservations for stays of thirty days or less that are canceled between time of booking and seventy-two hours (three days) prior to arrival are subject to a cancellation fee equal to one night's rental and taxes; Reservations canceled between seventy-two hours and the day of arrival will be subject to a cancellation fee equal to one week's rental and taxes. For reservations for a length-of-stay of thirty days or more that are canceled any time after booking will be subject to a cancellation penalty equal to one week's rental and taxes.
- **Assignment & Subletting** | Customer shall not assign the Campground Reservation and/or Golf Cart Rental or any interest herein or permit the use of the Campground Reservation and/or Golf Cart Rental or any part thereof by any other party. Customer shall not sublet or sublicense the Campground Reservation and/or Golf Cart Rental without the prior written consent of the World Equestrian Center. Any purported assignment by Customer shall be and constitute a material breach of this Agreement and shall be null and void.

VEHICLE, PRIVATE CARTS & GOLF CART RENTAL: GENERAL INFORMATION AND RULES



RENTAL TIMES

- Daily Rental Times: **Pick-up | 8am and later**
Return | 9pm and earlier
- Carts not returned to the General Store location are subject to a \$35 retrieval fee and a \$25 lost key fee
- Rental period is 24 hours from time of pick up (There is no pro-rating for returning carts earlier than original rental period)



ALWAYS USE CAUTION AROUND HORSES

- Horses **always** have the right of way; Use caution when approaching and maintain as much room as possible between horses and vehicle
- Do not tailgate or pass horses, mounted riders or carriages

CART GUIDELINES

- All drivers must have a valid driver's license and be 21 years or older to drive rental carts
- Driver's must obey all posted traffic signs and abide by all Florida Rules of the Road while on WEC property
- The 15mph speed limit is strictly enforced. Your golf cart speed is governed to adhere to this limit
- All motor vehicles, including golf carts, must use the paved roads only. No driving on the grass or in the barns
- Lights are required on all vehicles after sunset
- All passengers must be seated while the vehicle is in motion. Standing while in use is not permitted
- Drivers may not have open containers of alcohol while operating vehicles, nor be under the influence of alcohol or any other substances
- The use of any electronic communication device to send or read text messages, emails or any other written communication while operating a vehicle is prohibited. A hands-free device must be used for all cellular phone calls taking place while operating a vehicle
- Private carts must be golf style carts; Off-road, ATV, utility or construction-type carts are not permitted
- Private carts must register with the General Store RV desk and display provided tag
