2023 USEF MEMBERSHIP STATEMENT

Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Federation Entry Agreement: By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of Competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the the World Equestrian Center may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

(GR407.1-3) For every horse participating in any competition licensed by the Federation, a \$23 Federation Fee will be collected (\$15 shall be an Equine Drugs & Medication Fee to provide for research, inspection, and enforcement of rules regarding use of medications and drugs & \$8 USEF Fee) along with a \$7 USHJA Fee, for non-members USEF Showpass \$45 and USHJA Showpass \$30.

The Horse Show Management reserves the right in itself to interpret all questions and conditions in regard to or arising out of an incident without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management, their decision to be final.

The Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without claim for damages; to change any course, to add a dotted line, to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the time schedule or as competition warrants, or make any changes management deems is in the best interest of the show and its exhibitors.

Every horse entered for competition will be under the control of the Horse Show Management, but Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its members, directors and employees, contractors, sponsoring entities and facility harmless for any loss or accident to horse, horses or equipment which may occur from sickness, fire or otherwise

SAFE SPORT STATEMENT: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org.

NECROPSY: I understand that any horse/pony "fatality" defined as a death by any means including euthanasia, at any time from when entries arrives at the Venue until departure from the Venue, or a death by any means including euthanasia at any time occurring as a result of any fatal injury or illness sustained during any WEC Event shall result in a necropsy. For any necropsy the Owner of the horse/pony shall perform a gross mortem examination and the Owner hereby agrees to share all findings, results and medical reports with WEC. In the event an Owner does not perform a gross post mortem examination of the horse/pony, the Owner hereby authorizes WEC to perform the gross post mortem examination at its sole cost and expense and agrees to share the results with Owner.



Office Hours: Office closes at 5pm daily OR 30 minutes after the last class finishes, whichever comes FIRST. Adds for the next day must be completed by 4pm.

Important USEF rules in effect: As of Jan 1, 2019 every USEF adult member (18 years of age or older) with a Competing Membership must complete USEF's Safe Sport Training. You will do this when logged into your USEF account, preferably when you renew your membership. Failure to complete the safe sport training will disqualify you from competing in any capacity until it is completed. Do not get caught on the suspended list. Junior riders that have reached their 18th birthday must complete Safe Sport training.

Mandatory Microchipping went into effect on December 1, 2018. You will not be allowed to COMPETE any horse that has not been microchipped. The microchip must be uploaded to your USEF account. All horses that require a USHJA Registration will also require a microchip.

Stabling: All stalls (12'X12' and 12'X14') are permanent concrete stalls with doors, stable comfort mattress systems, and fans in a climate-controlled barn. Stalls may not be occupied by more than one horse at a time.

Circuit Stall/Paddock Reservations: Stalls are \$3090/circuit and must be secured with payment in full. Stalls will not be confirmed without payment. Stalls/paddocks can be ordered through www.showmanagementsystem.com until sold out. Stalls will be reserved once payment is received. Paddocks are \$3090/circuit and subject to availability and stall count

Same price cash or credit. Checks must be received within 10 days or reservations will be cancelled. We suggest using a trackable mailing service. Circuit items are refundable until October 10, 2022, less \$90 processing fee. Stalls/paddocks are property of World Equestrian Center. Circuit rentals may not be transferred to a third party without the express written consent of management. All horses on grounds will be charged for a stall or ship-in fee.

No reservations will be accepted through email. All reservations must use Show Management System regardless of method of payment. Reservations will be complete upon processing of payment and approval of World Equestrian Center. Please understand that we are unable to accept location requests at this time. Tack stall and paddock requests will be accommodated based on the ratio of horse stalls ordered

Weekly Stall/Paddock Reservations: Stalls are \$300/week and must be secured with payment in full. Stalls will not be confirmed without payment. Stalls/paddocks can be ordered through www.showmanagementsystem.com until sold out. Stalls will be reserved once payment is processed. Paddocks are \$350/week and subject to availability and stall count.

Paddock Restrictions: Horses may not be turned out in paddocks between dusk and dawn.

Feed and Bedding: Must be ordered through https://stallinfo.net at least 24 hours in advance to guarantee delivery prior to arrival. No outside shavings deliveries permitted.

Ship In Fee: \$50/week. Park in designated area only. Any horse not entered to show will also be charged the appropriate non showing fees.

*Entry Closing: Mailed entries must be received by December 21, 2022. Paper entry fee \$50/horse/week. Online entries must be submitted two weeks prior to the start of the competition week. Submit online entries through www.showmanagementsystem.com. Late fee is \$50 after the closing date for online entries/\$75 for paper entries. Late fee starting Tuesday of the show week is \$100

Checking In and Checking Out: All horses must leave a check or credit card on file. All accounts must be settled EVERY WEEK, in full, upon the conclusion of the final class on Sunday. Those that do not check out or leave an open check with the office will be charged a \$50 late check out fee.

IMPORTANT INFORMATION CONCERNING SPLITTING/COMBINING & ADD/SCRATCH POLICY IN ALL "A" RATED HUNTER SECTIONS: Should entries warrant, all "A" rated hunter sections will be split or combined following USEF rules and will be done so at the close of the horse show office on the evening preceding the first class in each section, therefore entries MUST be completed for "A" rated hunter divisions accordingly to be considered. Any post-adds received and accepted after this time will not be considered in respect to the splitting/ combining numbers. There will be no exceptions to this policy. Same day scratches and/or "no-shows" at the gate in all "A" rated hunter sections will forfeit their entry fee unless a Certificate from the Official Show Veterinarian vet scratch for the show is received by the official show secretary prior to the First class of the section in question. Should same day scratches or no-shows result in insufficient entries to keep sections split, sections will be combined.

Adding Classes: Can be done directly through Show Management System or in horse show office until 4pm the day before the class is scheduled. Please be sure to enter classes in a timely manner. Scheduling cannot accommodate same day adds. In the event an add after 4pm the day prior is approved by management, a \$25 late add fee will incur.

***RDNE (Rode Did Not Enter): Entries that show in a class that was not properly entered either online, by inclusion on your original entry form, or a properly filled out add slip/online add PRIOR to the class involved will be charged a \$50 RDNE Fee

Scratching Classes: Scratches can be done directly in your Show Management System account any time until the start of the class except "A" rated hunters cannot scratch same day. Informing the starter that you do not intend to participate WILL NOT scratch the class. A horse on the grounds scratching all classes will become a non-showing horse regardless of the reason and will incur all fees associated with a non-showing horse. After showing in the first class of any "A" rated section requiring a section entry fee, no refunds will be given for scratching any classes within the section for any reason.

Non-Showing Horses: All horses on the grounds are required to have a signed entry form in the office, whether they are showing or not. This entry form must include signatures and a complete description of the horse. Non-Showing horses (horses doing ticketed warmup, but no classes are considered non-showing horses) will pay a fee of \$150 per show plus \$18 night watch. Scratched horses on the grounds are considered non-showing horses regardless of the reason. All horses on the property must have signed entry blank and health paperwork submitted to the show office. Any horses found in violation will be fined \$250. Please see Health Requirements.

Award Ceremonies: Riders are required to ride for awards in all Classics/Grand Prix, unless notice of ceremony cancellation has been given. Failure of a rider to be present may result in forfeiture of all prizes won in the class. Competition management reserves the right to require participation in any tie-breaking procedure in order to determine a winner of a competition or championship. Refusal to participate in the tie-break procedure (if required) may include, but is not limited to; forfeiture of prize money and/or elimination from the competition. The decision of management is final.

Payment Method: Show Fees may be paid by cash, check drawn on an American bank, or any major credit card (3% fee).

Returned Checks/Declined Credit Cards/Credit card chargebacks: Checks returned by the bank or declined credit cards or chargebacks on credit cards transactions for any reason are regarded as a serious offense and will be handled as follows: A 10% penalty will be assessed for every returned check or credit card chargeback (Minimum of \$50). Accounts will be given ten days to be paid in full with cash or cash equivalent or they will be reported to USEF for collection/disciplinary action.

Prize Money/Awards: An IRS W9 needs to be completed showing the proper prize money recipient and their SS or FED ID#. Care must be taken to be sure the information matches that of the IRS. Prize money will be deducted from your account upon closeout in the office provided you have submitted the required W9 or W8 for Foreign exhibitors. Balances will be paid by check and mailed to the named recipient on the W9 within 30 days after the conclusion of the show. The IRS W9 form is available in the show office/through Show Management System account. All Hunter purses shall be divided as follows unless otherwise specified: 1st-30% / 2nd-22% / 3rd-15% / 4th-12% / 5th-11% / 6th-10%. Ribbons will be awarded to eighth place in all hunter classes. \$75,000 in hunter prize money is guaranteed to be paid out each week. \$121,350 in total hunter prize money is offered weekly.

CONDITIONS

Refunds: Entries canceled prior to the closing date will be refunded in full. Stalls and processing fee are not refundable for any reason. All scratches must be submitted in writing to be considered for a refund. All accounts become final after the close of the show, changes will not be considered after this date, no exceptions! Please look over your statement carefully before checking out. If the show must be stopped due to a storm, accident, or other emergency, the show management has the right to deny a refund of any or all fees. Refunds will be issued at the end of series.

Processing/EMT/Night Watch: Each horse will pay a \$50 per show Processing Fee, \$35 EMT Fee & Horse Ambulance fee, and \$18 Night Watch Fee. The Processing Fee is a non-refundable fee which will also entitle each horse to properly add/scratch regular classes at no additional cost.

Arrival and Departure: Horses may arrive after 3pm on Monday and depart no later than 7am Monday. Early arrival and late departure must be arranged directly with the stabling manager.

Health Requirements: Florida regulations require that all equines be covered by official interstate health certificates, issued by a licensed veterinarian, showing that the animals are free from any symptoms of any infectious or communicable disease. The œrtificate shall include the name of the owner and address, destination in Florida, number of horses examined, the name, registration number(s), if any, tattoo, if any, sex, age, rectal temperature, color, and markings of each animal listed. Health certificates will become void after 30 days from issue. Health certificates must show animals to be negative to an equine infectious anemia test within the past 12 months. Date of test and approved laboratory must be shown on health certificate. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in guestion received the vaccinations; name of the vaccines and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee.

Courtesy Circle: In some instances it may become necessary to restrict the area of the courtesy circle by a mandatory line. If this is implemented, it will be clearly marked on the course chart and a corresponding barrier will be erected on the course. A public announcement will also be made.

Motorized Vehicles: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of a minor operating and other mobility assistance devices for individuals with disabilities are exempt from this rule is accountable and may be subject to penalties. Dogs - Leash Law: Dogs and other pets must be on a leash at all times while on the show grounds. Fines may be imposed for dogs not on a leash.

RDNE (Rode Did Not Enter): Entries that show in a class that was not properly entered either online, by inclusion on your original entry form, or a properly filled out add slip/online add PRIOR to the class involved will be charged a \$25 RDNE Fee. All adds must be done by 4:00 P.M. the day before the class.

Medical Waste: Sharps must be placed in proper receptacles located in each barn. Failure to do this will result in a \$100 fine or other penalties deemed necessary by the show management.


Protective Headgear: It is compulsory for all persons at Federation licensed hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/ SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. It is the responsibility of the rider, or the parent, guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards and is properly fitted and in good condition.

Poling: Manual poling and the use of bamboo offsets are prohibited at all times on the grounds of the World Equestrian Center. In the event of a violation of this rule, the involved horse and its trainer of record as indicated on the entry form will be suspended from further competition at the show in which the violation occurred. In addition, no refunds will be given for any unused fees.

Emergency Information: All horses must have an emergency information card attached to their stall/completed online through www.stallinfo.net for contact purposes.

Horse Show Championships: In all Hunter Championships, the titles shall be awarded to two of the four horses which have acquired the most points over fences. In addition to these points, only these four horses shall receive full points for ribbons won in Under Saddle classes and half points for ribbons won in Model. Equitation Championships shall be equal points with ties broken by points over fences. Points awarded for all divisions as follows: 10-6-4-2-1-1/2 except Jumper bonus classes. Ties in USEF Hunter Championships shall be decided as specified in the USEF Rule Book. Others shall remain tied and shall flip/draw for the awards. Ties in Jumper divisions to be decided by the bonus class placing, if still tied they shall remain tied and entries shall flip/draw for the awards.

Horse/Pony Measurements: Measurements will take place Wednesday through Saturday at the Vet station in Barn E. Please make arrangements in the Horse Show Office.

All hunter classes that require a jog will be run with an open numerical score announced at the end of each round. Hunter Courses: Courses will consist of at least eight fences with changes of direction. Fences will simulate obstacles found in the hunt field, such as brush, post and rails, walls, in and outs, gates, etc. No bank or water jumps. Course diagrams will be posted no later than 30 minutes before the class. In some cases, the area of the courtesy circle may be restricted by a dotted line. Under Saddle classes to be shown at a walk, trot and canter both ways of the ring. No martingales permitted. In High Performance, A/O and Junior classes, entries may be asked to hand gallop collectively one way of the ring, at the Judge's discretion. No more than eight shall be asked to hand gallop at one time. Minimum entry requirements: Management reserves the right to combine Sections with less than six entries. No split Section will be held with less than four entries. Handy Hunter Courses and jumps to simulate those found in trappy hunt country, and may include natural obstacles, a trot fence and a fence to lead over. Jogging - The traditional manner of jogging for soundness in hunter classes is waived, and horses and ponies will jog for soundness under saddle by trotting a circle on a loose rein at the end of each over-fences performance.

Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and <u>WEC Ocala Winter Spectacular #1 - #12</u>("**USEF Event**" or "**USEF Events**"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B.
