## HORSE SHOW RULES

Every class offered herein which is covered by the rules and specifications of the current federation rule book.

### 2025 USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

**Federation Entry Agreement:** By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of 2024 Winter Spectacular Show Series (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules,

and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

**Show Pass Fee:** Effective 12-1-2022 any rider, handler, driver, or owner are limited to one Show Pass purchase annually (December 1-November 30). USEF Show Pass will be available for purchase by exhibitors online only. USEF membership will be required in order to compete (named on an entry form as owner, rider, trainer, or coach) for anyone who has not purchased a show pass at USEF.org.



## STATEMENT AS TO FEDERATION FEE

(GR407.1-3) For every horse participating in any competition licensed by the Federation, a \$23 Federation Fee will be collected (\$15 shall be an Equine Drugs & Medication Fee to provide for research, inspection, and enforcement of rules regarding use of medications and drugs & \$8 USEF Fee) along with a \$7 USHJA Fee and USHJA Showpass \$30. USEF Membership is required.

The Horse Show Management reserves the right in itself to interpret all questions and conditions in regard to or arising out of an incident without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management, their decision to be final.

The Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries,

and cancel award prizes, without claim for damages; to change any course, to add a dotted line, to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the time schedule or as competition warrants, or make any changes management deems is in the best interest of the show and its exhibitors.

Every horse entered for competition will be under the control of the Horse Show Management, but Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its members, directors and employees, contractors, sponsoring entities and facility harmless for any loss or accident to horse, horses or equipment which may occur from sickness, fire or otherwise

## SAFE SPORT STATEMENT

**Reminder:** All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. ## NECROPSY

I understand that any horse/pony “fatality” defined as a death by any means including euthanasia, at any time from when entries arrive at the Venue until departure from the Venue, or a death by any means including euthanasia at any time occurring as a result of any fatal injury or illness sustained during any WEC Event shall result in a necropsy. For any necropsy the Owner of the horse/pony shall perform a gross mortem examination, and the Owner hereby agrees to share all findings, results and medical reports with WEC. In the event an Owner does not perform a gross postmortem examination of

the horse/pony, the Owner hereby authorizes WEC to perform the gross postmortem examination at its sole cost and expense and agrees to share the results with Owner.

In the event an Owner’s horse/pony dies from a disease that affects (an)other horse(s)/pony(ies) at the Venue the Owner of the deceased horse/pony agrees to indemnify any other third party Owner of a horse/pony affected and further agrees to indemnify and hold WEC harmless from any claim, demand, or liability arising out of or in any way related to the deceased horse/pony.

## CONDITIONS

**Under Saddle and Flat classes will not be held up for trainer conflicts. It is the riders responsibility to be at the ring when the class is opened. Management and staff will not be responsible for missed flat classes.**

**Office Hours:** Office closes at 5pm daily or 30 minutes after the last class finishes, whichever comes first. Adds for the next day must be completed by 4pm.

**Entry Form:** All horses on the grounds MUST have an entry form submitted BEFORE arrival. Any horse discovered on the grounds without a signed entry will pay a \$500 penalty over and above all the regular fees for a non showing or showing horse. This is to protect everyone as all horses must show appropriate health papers upon arrival.

All competing horses must have a USEF Identification Number as well as a valid microchip number associated with that USEF Identification Number. All competing horses must have a lifetime USHJA registration unless they are only competing in Walk, Trot or Opportunity classes.

**Back Numbers:** Assigned back numbers must be worn in all exercise, schooling and lunging areas.

**Air Vests:** Air vests are allowed (and encouraged) in all disciplines. For hunter and equitation classes, judges are instructed to not deduct points for the use of an air vest. Please understand that the show will not be delayed in order to reset the air vest. Riders who choose to wear air vests are therefore strongly encouraged to have spare equipment (air canisters, tether, and entire vest) ringside so the vests that have inflated can quickly be returned to operation. Air vests are permitted without a show coat ONLY if being worn with a color matched, long sleeve, collared shirt.

**Scratching Classes:** Adds for the next day, if done in the office, must be done before the office closes. Same day adds will likely be denied. Online adds will remain open until 5pm regardless of the finish time of the show, even if the show ends later than 5pm. Scratches can be done online or in the office until the results of that class are posted, after this time the class will not be removed from your bill regardless of the reason. The Gate Attendants have NO ABILITY to remove a class from your account, it must be done online or in the office. Be aware of the exceptions below.

**IMPORTANT INFORMATION CONCERNING SPLITTING/COMBINING & ADD/SCRATCH POLICY IN ALL "A" RATED HUNTER SECTIONS THAT REQUIRE A SECTION FEE** – Should entries warrant, all included sections will be split or combined following USEF rules and will be done so at the close of the horse show office on the evening preceding the first class in each section, therefore entries MUST be completed for "A" rated hunter divisions accordingly to be considered. Any post-adds received and accepted after

this time will not be considered in respect to the splitting/combining numbers. There will be no exceptions to this policy. Same day scratches and/or "no-shows" at the gate in all "A" rated hunter sections will forfeit their entry fee unless a Certificate from the Official Show Veterinarian vet scratch for the show is received by the official show secretary prior to the First class of the section in question. Should same day scratches or no-shows result in insufficient entries to keep sections split, sections will be combined.

**Processing/EMT/Night Watch/Schooling Fee:** Will be shown on your invoice as ADMIN Fee and covers Office, EMT, Schooling and Night Watch Fee. \$145. \$50 of this fee is non-refundable in the case of a scratched entry.

**Payment Method:** Show Fees/bedding/feed may be paid by cash, check drawn on an American bank, or any major credit card (@3% fee).

**Foreign Checks:** All foreign exhibitors must pay by credit card, cash or a check drawn on a US Bank.

**Refunds:** Entries canceled prior to the closing date will be refunded in full. Stalls and \$50 of the processing fee are not refundable for any reason after the closing date of stalls. All scratches must be submitted in writing (stalls@wec.net) to be considered for a refund. No other method is valid. All accounts become final after the close of the show, changes will not be considered after this date, no exceptions! Please look over your statement carefully BEFORE checking out. If the show must be stopped due to a storm, accident, or other emergency, the show management has the right to deny a refund of any or all fees.

**Safe Sport Training:** As of January 1, 2019 every USEF adult member (18 years of age or older) with a Competing Membership must complete USEF's Safe Sport Training. You will do this when logged into your USEF account, preferably when you renew your membership. Failure to complete the safe sport training will disqualify you from competing in any capacity until it is completed. Don't get caught on the suspended list! Do it today!! Junior riders that have reached their 18 Birthday must complete safe sport.

**Earbuds:** Earbuds or earphones are prohibited in any areas designated for schooling and exercise including lunging areas.

**Stabling:** Most stalls are permanent wood construction with Dutch doors for outside air and rubber mats, 10x12 with doors; some may be 10x10 with doors. When submitting

your reservation please put in the NOTES portion any special needs you may have.

**Aisles:** Aisles must be kept clear, please purchase a tack stall to store tack trucks, hay, feed, Theraplates, etc. A tack stall is required if you have 3 or more horses. No cross ties in aisles at any time. No loitering will be permitted in barn aisles. No horses or dogs are permitted to be tied in the aisles. No tacking or grooming in aisles. Dogs on leashes must not be able to access the aisle unless attached to a human as it is dangerous for horses and people passing by.

**Stall Reservations:** Stalls for horses will be \$250 and must be secured with your reservation with payment in full, open check or credit card. The cancelation deadline is the Tuesday 21 days before the start of the competition, after that stalls will not be refunded for any reason. If not prepaid then the credit card or open check on file will be executed. Any stall occupied by anything other than a horse will be billed at \$250 (considered a tack stall), and do not need to be prepaid. Horse stalls and tack Stalls must be ordered on HorseShowing.com, you will need to have a free account. Be sure to use the STALLS/FEED AND BEDDING option, this feature will be turned off when the available supply is exhausted. Stalls are not available on entries but should you have a confirmed stall you can pay a \$250 ENTRY DEPOSIT online at time of entry submission in lieu of sending an open check.

**Arrival and Departure:** Horses may arrive after 3pm on Monday and depart no later than 7am your final Monday. Early arrival and late departure must be arranged directly with the stabling manager in writing, stalls@wec.net . \$40 per day fee will apply for those that have permission to arrive early. Your stall location might be in a different area until your assigned stalls are available. Any stalls not vacated by 7am on Monday will be billed at a rate of \$50 per hour for every hour past 7am. No exceptions. If you have an emergency of any kind that delays your departure you will likely have to move horses to an outer barn.

**Health Requirements:** All horses entering the World Equestrian Center grounds must have valid proof of negative coggins test (within 12 months). Proof of mandatory vaccinations is required per USEF rules. A 30 day certificate of veterinary inspection is required for all horses arriving from outside the state of Ohio. Horses who fail to arrive with appropriate paperwork will not be allowed to unload on show grounds. Documents should be emailed to ohhealth@wec.net

**Feed and Bedding:** Should be ordered online by Friday prior to your arrival to guarantee they will be delivered prior to your arrival. Once stalls are occupied it may not be possible to get in front of your stalls so orders will be left outside the door. You can order additional product throughout the show using your horseshowing.com account . Slips are also available in

the show office. Once an order has been delivered we do not accept returns. In certain cases a restocking fee may apply at managements discretion..

**Grounds Fee:** All horses must purchase a stall, we do not have accommodations for showing out of trailers.

**Non-Showing Horses:** All horses on the grounds are required to have a signed entry form in the office, whether they are showing or not. This entry form must include signatures and a complete description of the horse. Non-Showing horses will pay a fee of \$150 per show plus fees. Competing in 3 classes, or at least \$150 in entry fees will be considered a showing horse. Scratched horses on the grounds are considered non-showing horses regardless of the reason.

**Prize Money/Awards:** The proper taxpayer MUST be declared every week, if we already have your W9 then do a VERBAL declaration no later than the close of business on Saturday, prize money is withheld until this is declared. An IRS/W9 needs to be completed once a year showing the proper prize money recipient and their SS or FED ID#. Care must be taken to be sure the information matches that of the IRS. Prize money will be deducted from your account upon closeout in the office provided you have submitted the required W9, or W8 for Foreign exhibitors, no later than Saturday. We cannot take the necessary time to verify your W9 against IRS records on Sunday, therefore you will need to pay you bill in full and a check will be mailed after the W9 has passed the IRS checker. Balances will be paid in the form of a check mailed to the named recipient on the W9 within 30 days after the conclusion of the show. The IRS W9 form is available in the show office. Prize money will not be paid in any classes that are run with less than 3 entries or the minimum required entries, if held they will become schooling classes. Ribbons to a minimum of 8 places will be given in all hunter, jumper and equitation classes.

**Check Out:** Check out is easy at WEC

1. You can print your statement at the exhibitors terminal and drop your check in the box on the counter.
2. You can check out directly on the exhibitors terminal with a credit card.
3. You can TEXT Julie at 248-892-6806 with your back number and request an emailed statement that will have a direct PAY HERE link.
4. You can check out directly with us at the counter.

Regardless of how you do it, you MUST settle your account at the end of each week. If you want us to check you out after you are done showing you MUST pre-arrange that. Be sure to check your statement carefully before checking out, they become final at the conclusion of the show. Failure to check out will cause a \$50 per day per entry penalty starting at midnight Sunday night.



## CONDITIONS

**Reminder:** All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. **Returned Checks/Credit Card Chargebacks:** Checks returned by the bank, declined credit cards, or chargebacks on credit card transactions for any reason are regarded as a most serious offense and will be handled as follows: A 10% Penalty will be assessed for every returned check or credit card chargeback (Minimum of \$50). Accounts will be given ten days to be paid in full with cash or cash equivalent or they will be reported to USEF for collection/disciplinary action. Accounts may also be turned in to the County Attorney's Office for filing of criminal charges.

All purses shall be divided as follows unless otherwise specified: 1st-30% / 2nd-22% / 3rd-15% / 4th-12% / 5th-11% / 6th-10%.

**Rings:** Roberts is 110' x 266', R & L Ring is 130' x 300', R & L Annex Ring is 130' x 300' Sanctuary 170 X 325, Main Hunter outside 280' X 152', Hunter 2 Outside 280' X 150', Jumper Ring outside 300' X 250'. All are GGT Mix.

Roberts Ring 110' x 266'

R&L Annex Ring 130' x 300'

Sanctuary Ring 170 X 325

**Lunging:** We have a 100' X 300' dedicated lunging indoor arena that is open 24 hours as well as a 130' X 270' outdoor ring across from barn A, 55' X 145' indoor for lunging adjacent to the Roberts Ring, and 220' X 315" outdoor ring behind the cabins. No lunging in Show Rings. All lunging areas are GGT mix except the Cabin ring is sand.

**Courtesy Circle-**In some instances it may become necessary to restrict the area of the courtesy circle by a mandatory line. If this is implemented it will be clearly marked on the course chart and a corresponding barrier will be erected on the course. A public announcement will also be made.

**Motorized Vehicles:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. Scooters used indoors MUST come to a complete stop at every turn and intersection. All other motorized vehicles are not permitted to be used indoors.

**Dogs - Leash Law:** Dogs and other pets must be on a leash at all times while on the show grounds. Please do not tie dogs in aisles.

**RDNE (Rode Did Not Enter):** Entries that show in a class that was not properly entered either online, by inclusion on your original entry, or a properly filled out add slip PRIOR to the class involved will be charged double the entry fee, and you will not be considered for an award in that class. This charge will show on your statement as "entered off judge's card". All adds must be completed by 5:00 P.M. the day before the class in question to assure acceptance.

**Medical Waste:** Sharps must be placed in proper receptacles located in each barn. Failure to do this will result in a \$100 fine or other penalties deemed necessary by the show management.

## CONDITIONS

**Protective Headgear:** It is compulsory for all persons at Federation licensed hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. It is the responsibility of the rider, or the parent, guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards and is properly fitted and in good condition.

**Poling:** Manual poling and the use of bamboo offsets are prohibited at all times on the grounds of the World Equestrian Center. In the event of a violation of this rule, the involved horse and its trainer of record as indicated on the entry form will be suspended from further competition at the show in which the violation occurred. In addition, no refunds will be given for any unused fees.

**Emergency Information:** 24 hour security can be reached at 937.269.1191 or 937.382.7878. All horses must have an emergency information card attached to their stall for contact purposes.

**Horse Show Championships:** In all Hunter and Equitation Championships, the titles shall be awarded to two of the four horses which have acquired the most points over fences. In ad-

dition to these points, only these four horses shall receive full points for ribbons won in Under Saddle classes and half points for ribbons won in Model. Points awarded for all divisions as follows: 10-6-4-2-1-1/2 except Jumper bonus classes. Ties in USEF Hunter Championships shall be decided as specified in the USEF Rule Book. Others shall remain tied and shall flip/draw for the awards. Ties in Jumper divisions to be decided by the bonus class placing, if still tied they shall remain tied and entries shall flip/draw for the awards.

**Camping Sites:** Camper spaces are available for \$300 per show, reservations should be included on your entry or stall reservation. Campers can arrive on Monday and must vacate by your final Monday by 7am. Park your camper then call the phone number that is available in the lot to get your utilities opened up. Failure to call security or declare your campers location in the show office will be subject to a penalty of \$500. It is possible in some cases to leave your camper on your off weeks.

**Credentials Needed:** On occasion there is something that the office must have prior to you checking out that may trigger a "credentials needed" fee of a large amount of money. This is just a label that will prevent you from checking out without completing whatever the office needs. It is just a label, you will not be charged the fee, it is never intended to be an actual charge.

**Horse Recording:** All horses competing in this competition must possess an USHJA Horse Registration - \$75.00 for life. Any change of horse's name and/or ownership must be recorded with Federation. Horses competing for \$25,000 or higher classes must be RECORDED with USEF.

**Poling:** Manual Poling is not permitted.

**Order of Go:** In the Welcome Prix, Futures Prix, Grand Prix, and all Sunday Classic and any where management deems necessary all horses names and positions will be drawn by the computer. In cases with riders on multiple mounts the computer will adjust the order, if necessary, to a minimum of 8 horses between rides (where possible). These orders will be

drawn 30 minutes after the last jumper class finishes the day before OR at 5pm, whichever comes first. Any adds after that time will go to the top of the order.

# WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves inherent risks and dangers. "Inherent risk of an equine activity" means a danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following: (a) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine; (b) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals; (c) Hazards, including, but not limited to, surface or subsurface conditions; (d) A collision with another equine, another animal, a person, or an object; (e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant; (f) the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; (g) loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; (h) exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; (i) contact or collision with other participants and horses, natural or manmade objects; (j) adverse weather conditions; (k) facilities issues and premises conditions; (l) failure of protective equipment (including helmets); (m) inadequate safety measures; (n) participants of varying skill levels; (o) situations beyond the immediate control of the USEF Event organizers and competition management; and (p) other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

## EQUINE ACTIVITY LIABILITY ACT WARNING:

CAUTION: HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK.

**Under the laws of most States, an equine activity sponsor or equine professional is not liable for any injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.**

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

By signing below, I (as the participant or as the Parent/Legal Guardian of the minor identified below) hereby accept and agree to the terms and conditions of this Agreement in connection with my (or the minor's) participation in any USEF Event. If, despite this Agreement, I, or anyone on my behalf or the minor's behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities as the result of such claim.

**The parties agree that this agreement may be electronically signed. The parties agree that the electronic signatures appearing on this agreement are the same as handwritten signatures for the purposes of validity, enforceability, and admissibility.**

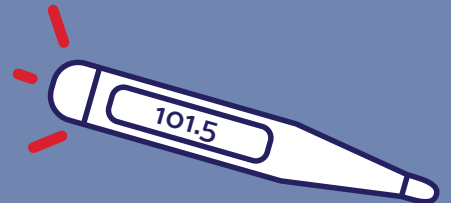

## HORSE SHOW RULES

**Every class offered herein which is covered by the rules and specifications of the current federation rule book and current fei rules will be conducted and judged in accordance therewith.**

## 2025 USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

**Federation Entry Agreement:** By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of 2024 Winter Spectacular Show Series (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules,

and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

**Show Pass Fee:** Effective 12-1-2022 any rider, handler, driver, or owner are limited to one Show Pass purchase annually (December 1-November 30). USEF Show Pass will be available for purchase by exhibitors online only. USEF membership will be required in order to compete (named on an entry form as owner, rider, trainer, or coach) for anyone who has not purchased a show pass at USEF.org.

## STATEMENT AS TO FEDERATION FEE

(GR407.1-3) For every horse participating in any competition licensed by the Federation, a \$23 Federation Fee will be collected (\$15 shall be an Equine Drugs & Medication Fee to provide for research, inspection, and enforcement of rules regarding use of medications and drugs & \$8 USEF Fee) along with a \$7 USHJA Fee and USHJA Showpass \$30. USEF Membership is required.

The Horse Show Management reserves the right in itself to interpret all questions and conditions in regard to or arising out of an incident without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management, their decision to be final.

The Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries,

and cancel award prizes, without claim for damages; to change any course, to add a dotted line, to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the time schedule or as competition warrants, or make any changes management deems is in the best interest of the show and its exhibitors.

Every horse entered for competition will be under the control of the Horse Show Management, but Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its members, directors and employees, contractors, sponsoring entities and facility harmless for any loss or accident to horse, horses or equipment which may occur from sickness, fire or otherwise

## SAFE SPORT STATEMENT

**Reminder:** All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org).

## NECROPSY

I understand that any horse/pony “fatality” defined as a death by any means including euthanasia, at any time from when entries arrive at the Venue until departure from the Venue, or a death by any means including euthanasia at any time occurring as a result of any fatal injury or illness sustained during any WEC Event shall result in a necropsy. For any necropsy the Owner of the horse/pony shall perform a gross mortem examination, and the Owner hereby agrees to share all findings, results and medical reports with WEC. In the event an Owner does not perform a gross postmortem examination of

the horse/pony, the Owner hereby authorizes WEC to perform the gross postmortem examination at its sole cost and expense and agrees to share the results with Owner.

In the event an Owner’s horse/pony dies from a disease that affects (an)other horse(s)/pony(ies) at the Venue the Owner of the deceased horse/pony agrees to indemnify any other third party Owner of a horse/pony affected and further agrees to indemnify and hold WEC harmless from any claim, demand, or liability arising out of or in any way related to the deceased horse/pony.



## CONDITIONS

**Under Saddle and Flat classes will not be held up for trainer conflicts. It is the riders responsibility to be at the ring when the class is opened. Management and staff will not be responsible for missed flat classes.**

**Office Hours:** Office closes at 5pm daily or 30 minutes after the last class finishes, whichever comes first. Adds for the next day must be completed by 4pm.

**Entry Form:** All horses on the grounds MUST have an entry form submitted BEFORE arrival. Any horse discovered on the grounds without a signed entry will pay a \$500 penalty over and above all the regular fees for a non showing or showing horse. This is to protect everyone as all horses must show appropriate health papers upon arrival.

All competing horses must have a USEF Identification Number as well as a valid microchip number associated with that USEF Identification Number. All competing horses must have a lifetime USHJA registration unless they are only competing in Walk, Trot or Opportunity classes.

**Back Numbers:** Assigned back numbers must be worn in all exercise, schooling and lunging areas.

**Air Vests:** Air vests are allowed (and encouraged) in all disciplines. For hunter and equitation classes, judges are instructed to not deduct points for the use of an air vest. Please understand that the show will not be delayed in order to reset the air vest. Riders who choose to wear air vests are therefore strongly encouraged to have spare equipment (air canisters, tether, and entire vest) ringside so the vests that have inflated can quickly be returned to operation. Air vests are permitted without a show coat ONLY if being worn with a color matched, long sleeve, collared shirt.

**Scratching Classes:** Adds for the next day, if done in the office, must be done before the office closes. Same day adds will likely be denied. Online adds will remain open until 5pm regardless of the finish time of the show, even if the show ends later than 5pm. Scratches can be done online or in the office until the results of that class are posted, after this time the class will not be removed from your bill regardless of the reason. The Gate Attendants have NO ABILITY to remove a class from your account, it must be done online or in the office. Be aware of the exceptions below.

**IMPORTANT INFORMATION CONCERNING SPLITTING/COMBINING & ADD/SCRATCH POLICY IN ALL "A" RATED HUNTER SECTIONS THAT REQUIRE A SECTION FEE** – Should entries warrant, all included sections will be split or combined following USEF rules and will be done so at the close of the horse show office on the evening preceding the first class in each section, therefore entries MUST be completed for "A" rated hunter divisions accordingly to be considered. Any post-adds received and accepted after

this time will not be considered in respect to the splitting/combining numbers. There will be no exceptions to this policy. Same day scratches and/or "no-shows" at the gate in all "A" rated hunter sections will forfeit their entry fee unless a Certificate from the Official Show Veterinarian vet scratch for the show is received by the official show secretary prior to the First class of the section in question. Should same day scratches or no-shows result in insufficient entries to keep sections split, sections will be combined.

**Processing/EMT/Night Watch/Schooling Fee:** Will be shown on your invoice as ADMIN Fee and covers Office, EMT, Schooling and Night Watch Fee. \$145. \$50 of this fee is non-refundable in the case of a scratched entry.

**Payment Method:** Show Fees/bedding/feed may be paid by cash, check drawn on an American bank, or any major credit card (@3% fee).

**Foreign Checks:** All foreign exhibitors must pay by credit card, cash or a check drawn on a US Bank.

**Refunds:** Entries canceled prior to the closing date will be refunded in full. Stalls and \$50 of the processing fee are not refundable for any reason after the closing date of stalls. All scratches must be submitted in writing (stalls@wec.net) to be considered for a refund. No other method is valid. All accounts become final after the close of the show, changes will not be considered after this date, no exceptions! Please look over your statement carefully BEFORE checking out. If the show must be stopped due to a storm, accident, or other emergency, the show management has the right to deny a refund of any or all fees.

**Safe Sport Training:** As of January 1, 2019 every USEF adult member (18 years of age or older) with a Competing Membership must complete USEF's Safe Sport Training. You will do this when logged into your USEF account, preferably when you renew your membership. Failure to complete the safe sport training will disqualify you from competing in any capacity until it is completed. Don't get caught on the suspended list! Do it today!! Junior riders that have reached their 18 Birthday must complete safe sport.

**Earbuds:** Earbuds or earphones are prohibited in any areas designated for schooling and exercise including lunging areas.

**Stabling:** Most stalls are permanent wood construction with Dutch doors for outside air and rubber mats, 10x12 with doors; some may be 10x10 with doors. When submitting

your reservation please put in the NOTES portion any special needs you may have.

**Aisles:** Aisles must be kept clear, please purchase a tack stall to store tack trucks, hay, feed, Theraplates, etc. A tack stall is required if you have 3 or more horses. No cross ties in aisles at any time. No loitering will be permitted in barn aisles. No horses or dogs are permitted to be tied in the aisles. No tacking or grooming in aisles. Dogs on leashes must not be able to access the aisle unless attached to a human as it is dangerous for horses and people passing by.

**Stall Reservations:** Stalls for horses will be \$250 and must be secured with your reservation with payment in full, open check or credit card. The cancelation deadline is the Tuesday 21 days before the start of the competition, after that stalls will not be refunded for any reason. If not prepaid then the credit card or open check on file will be executed. Any stall occupied by anything other than a horse will be billed at \$250 (considered a tack stall), and do not need to be prepaid. Horse stalls and tack Stalls must be ordered on HorseShowing.com, you will need to have a free account. Be sure to use the STALLS/FEED AND BEDDING option, this feature will be turned off when the available supply is exhausted. Stalls are not available on entries but should you have a confirmed stall you can pay a \$250 ENTRY DEPOSIT online at time of entry submission in lieu of sending an open check.

**Arrival and Departure:** Horses may arrive after 3pm on Monday and depart no later than 7am your final Monday. Early arrival and late departure must be arranged directly with the stabling manager in writing, stalls@wec.net . \$40 per day fee will apply for those that have permission to arrive early. Your stall location might be in a different area until your assigned stalls are available. Any stalls not vacated by 7am on Monday will be billed at a rate of \$50 per hour for every hour past 7am. No exceptions. If you have an emergency of any kind that delays your departure you will likely have to move horses to an outer barn.

**Health Requirements:** All horses entering the World Equestrian Center grounds must have valid proof of negative coggins test (within 12 months). Proof of mandatory vaccinations is required per USEF rules. A 30 day certificate of veterinary inspection is required for all horses arriving from outside the state of Ohio. Horses who fail to arrive with appropriate paperwork will not be allowed to unload on show grounds. Documents should be emailed to ohhealth@wec.net

**Feed and Bedding:** Should be ordered online by Friday prior to your arrival to guarantee they will be delivered prior to your arrival. Once stalls are occupied it may not be possible to get in front of your stalls so orders will be left outside the door. You can order additional product throughout the show using your horseshowing.com account . Slips are also available in

the show office. Once an order has been delivered we do not accept returns. In certain cases a restocking fee may apply at managements discretion..

**Grounds Fee:** All horses must purchase a stall, we do not have accommodations for showing out of trailers.

**Non-Showing Horses:** All horses on the grounds are required to have a signed entry form in the office, whether they are showing or not. This entry form must include signatures and a complete description of the horse. Non-Showing horses will pay a fee of \$150 per show plus fees. Competing in 3 classes, or at least \$150 in entry fees will be considered a showing horse. Scratched horses on the grounds are considered non-showing horses regardless of the reason.

**Prize Money/Awards:** The proper taxpayer MUST be declared every week, if we already have your W9 then do a VERBAL declaration no later than the close of business on Saturday, prize money is withheld until this is declared. An IRS/W9 needs to be completed once a year showing the proper prize money recipient and their SS or FED ID#. Care must be taken to be sure the information matches that of the IRS. Prize money will be deducted from your account upon closeout in the office provided you have submitted the required W9, or W8 for Foreign exhibitors, no later than Saturday. We cannot take the necessary time to verify your W9 against IRS records on Sunday, therefore you will need to pay you bill in full and a check will be mailed after the W9 has passed the IRS checker. Balances will be paid in the form of a check mailed to the named recipient on the W9 within 30 days after the conclusion of the show. The IRS W9 form is available in the show office. Prize money will not be paid in any classes that are run with less than 3 entries or the minimum required entries, if held they will become schooling classes. Ribbons to a minimum of 8 places will be given in all hunter, jumper and equitation classes.

**Check Out:** Check out is easy at WEC

1. You can print your statement at the exhibitors terminal and drop your check in the box on the counter.
2. You can check out directly on the exhibitors terminal with a credit card.
3. You can TEXT Julie at 248-892-6806 with your back number and request an emailed statement that will have a direct PAY HERE link.
4. You can check out directly with us at the counter.

Regardless of how you do it, you MUST settle your account at the end of each week. If you want us to check you out after you are done showing you MUST pre-arrange that. Be sure to check your statement carefully before checking out, they become final at the conclusion of the show. Failure to check out will cause a \$50 per day per entry penalty starting at midnight Sunday night.

## CONDITIONS

**Reminder:** All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org)

**Returned Checks/Credit Card Chargebacks:** Checks returned by the bank, declined credit cards, or chargebacks on credit card transactions for any reason are regarded as a most serious offense and will be handled as follows: A 10% Penalty will be assessed for every returned check or credit card chargeback (Minimum of \$50). Accounts will be given ten days to be paid in full with cash or cash equivalent or they will be reported to USEF for collection/disciplinary action. Accounts may also be turned in to the County Attorney's Office for filing of criminal charges.

All purses shall be divided as follows unless otherwise specified: 1st-30% / 2nd-22% / 3rd-15% / 4th-12% / 5th-11% / 6th-10%.

**Lunging:** We have a 100' X 300' dedicated lunging indoor arena that is open 24 hours as well as a 130' X 270' outdoor ring across from barn A, 55' X 145' indoor for lunging adjacent to the Roberts Ring, and 220' X 315" outdoor ring behind the cabins. No lunging in Show Rings. All lunging areas are GGT mix except the Cabin ring is sand.

**Courtesy Circle-**In some instances it may become necessary to restrict the area of the courtesy circle by a mandatory line. If this is implemented it will be clearly marked on the course chart and a corresponding barrier will be erected on the course. A public announcement will also be made.

**Motorized Vehicles:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. Scooters used indoors MUST come to a complete stop at every turn and intersection. All other motorized vehicles are not permitted to be used indoors.

**Dogs - Leash Law:** Dogs and other pets must be on a leash at all times while on the show grounds. Please do not tie dogs in aisles.

**RDNE (Rode Did Not Enter):** Entries that show in a class that was not properly entered either online, by inclusion on your original entry, or a properly filled out add slip PRIOR to the class involved will be charged double the entry fee, and you will not be considered for an award in that class. This charge will show on your statement as "entered off judge's card". All adds must be completed by 5:00 P.M. the day before the class in question to assure acceptance.

**Medical Waste:** Sharps must be placed in proper receptacles located in each barn. Failure to do this will result in a \$100 fine or other penalties deemed necessary by the show management.

## CONDITIONS

**Protective Headgear:** It is compulsory for all persons at Federation licensed hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. It is the responsibility of the rider, or the parent, guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards and is properly fitted and in good condition.

**Poling:** Manual poling and the use of bamboo offsets are prohibited at all times on the grounds of the World Equestrian Center. In the event of a violation of this rule, the involved horse and its trainer of record as indicated on the entry form will be suspended from further competition at the show in which the violation occurred. In addition, no refunds will be given for any unused fees.

**Emergency Information:** 24 hour security can be reached at 937.269.1191 or 937.382.7878. All horses must have an emergency information card attached to their stall for contact purposes.

**Horse Show Championships:** In all Hunter and Equitation Championships, the titles shall be awarded to two of the four horses which have acquired the most points over fences. In ad-

dition to these points, only these four horses shall receive full points for ribbons won in Under Saddle classes and half points for ribbons won in Model. Points awarded for all divisions as follows: 10-6-4-2-1-1/2 except Jumper bonus classes. Ties in USEF Hunter Championships shall be decided as specified in the USEF Rule Book. Others shall remain tied and shall flip/draw for the awards. Ties in Jumper divisions to be decided by the bonus class placing, if still tied they shall remain tied and entries shall flip/draw for the awards.

**Camping Sites:** Camper spaces are available for \$300 per show, reservations should be included on your entry or stall reservation. Campers can arrive on Monday and must vacate by your final Monday by 7am. Park your camper then call the phone number that is available in the lot to get your utilities opened up. Failure to call security or declare your campers location in the show office will be subject to a penalty of \$500. It is possible in some cases to leave your camper on your off weeks.

**Credentials Needed:** On occasion there is something that the office must have prior to you checking out that may trigger a "credentials needed" fee of a large amount of money. This is just a label that will prevent you from checking out without completing whatever the office needs. It is just a label, you will not be charged the fee, it is never intended to be an actual charge.

## HUNTER DIVISIONS – PREMIER SHOWS

The rated sections of this competition are official USEF point competitions for USEF National and USEF Zone Horse of the Year Awards Programs. All hunter classes to be judged on performance and soundness. All Hunter classes requiring a jog will utilize the trot a circle at the end of their round on a loose rein format.

**Hunter Courses:** Courses will consist of at least eight fences with changes of direction. Fences will simulate obstacles found in the hunt field, such as brush, post and rails, walls, in and outs, gates, etc. No bank or water jumps. Course diagrams will be posted no later than 30 minutes before the class. In some cases, the area of the courtesy circle may be restricted by a dotted line. Under Saddle classes to be shown at a walk, trot and canter both ways of the ring. No martingales permitted. In High Performance, A/O and Junior classes, entries may be asked to hand gallop collectively one way of the ring, at the Judge's discretion. No more than eight shall be asked to hand

gallop at one time. Minimum entry requirements: Management reserves the right to combine Sections with less than six entries. No split Section will be held with less than 3 entries. Handy Hunter Courses and jumps to simulate those found in trappy hunt country, and may include natural obstacles, a trot fence and a fence to lead over.

**Jogging:** In all hunter classes requiring the horses to jog for soundness Option A will be utilized. Horses/Ponies are required to trot a circle on a loose rein at the end of each over fences performance.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves inherent risks and dangers. "Inherent risk of an equine activity" means a danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following: (a) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine; (b) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals; (c) Hazards, including, but not limited to, surface or subsurface conditions; (d) A collision with another equine, another animal, a person, or an object; (e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant; (f) the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; (g) loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; (h) exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; (i) contact or collision with other participants and horses, natural or manmade objects; (j) adverse weather conditions; (k) facilities issues and premises conditions; (l) failure of protective equipment (including helmets); (m) inadequate safety measures; (n) participants of varying skill levels; (o) situations beyond the immediate control of the USEF Event organizers and competition management; and (p) other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

**Poling:** Manual Poling is not permitted.

**Order of Go:** In the Welcome Prix, Futures Prix, Grand Prix, and all Sunday Classic and any where management deems necessary all horses names and positions will be drawn by the computer. In cases with riders on multiple mounts the computer will adjust the order, if necessary, to a minimum of 8 horses between rides (where possible). These orders will be

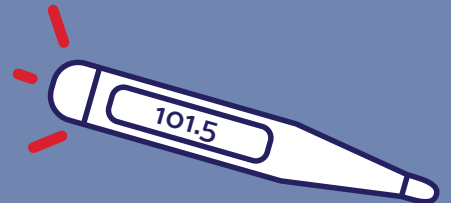
